

To whom it concerns,

- The intent of this email is to bring to the attention of An Garda Siochana evidence of what is most likely to be 3,616 murders in Ireland by and as such is likely to be the largest (by victim count) murder case in the history of the Irish State and also the Irish State's involvement with harm to pregnant women, still births and the and miscarriages of Irish babies.
- This This communication has been compiled very carefully with the utmost sincerity on my part and has in no way been compiled as an elaborate hoax to waste Garda time (as scrutiny of the source data will attest).
- The presented evidence is from official Government sources from the U.S., UK and EU.
- For An Garda Siochana the case could not be more complex because the evidence will show that the principal defendants are the Ministers, TDs, Senators of Irish Government – the employer of An Garda Siochana.
- Some members of the Irish Government are unwitting accessories and others operate in full knowledge.
- Putting the evidence presented here to the full rigor of investigative scrutiny:
 - o should probably take no more that 12 hours of Garda time
 - o concerning the accusation that the Government is engaged in democide, the evidence presented is
 - § Unambiguous
 - § Incontrovertible (i.e. official Government data)
 - § Easily independently verifiable and
 - § Lists numerous persons that can act as expert witnesses in and Irish court of law for the prosecution
- This is no conspiracy theory: the great preponderance (but not quite all) of the evidence presented here that can be directly employed to secure convictions of murder comes from official Government sources from the UK, US and the EU. Anecdotal evidence is also presented from medical professionals reporting firsthand accounts of their own experiences and these have been added as their reports support the official data presented.

- The evidence presented here will demolish the prima facie case that the State is working to protect the Irish people and will conclusively prove that they are in fact in the process of murdering Irish Citizens.
- As a corollary, the overwhelming majority of medical professionals working in Ireland are also guilty as contributory accessories to these murders and so too are most Mainstream media pundits.
- In the interests of full transparency all members of the Dail and Seanad and Irish mainstream media outlets (many of whom shall become the accused in this case) are cc'd on this correspondence. Any member of the Government canvassing Gardai to have this investigation quashed are guilty of conspiring to pervert the course of justice and should be arrested and tried accordingly. Those that are guilty would rather this case be filed away as baseless conspiracy, but the presented evidence is factual not theoretical and is therefore inescapable. Those that are innocent and those that have acted as unwitting accomplices will wish to do their respective duties and ensure that justice prevails.
- As for myself, I am aware of numerous threats against whistleblowers and even the [alleged murder of one of their number](#) so the only information I am willing to divulge at present is my email address and for now I shall not be answering any correspondence. If the Gardai are seen publicly to charge the accused and succeed in having them arraigned in a court of law I can liaise further thereafter and offer further evidence surrounding the context and motivation behind these crimes. For now the important thing is to start the ball rolling on prosecution of the criminals involved in these deaths.

PRESENTATION OF EVIDENCE:

Worldwide citizens in every country take it as an article of faith that their country's medical regulators will protect them by banning the sale of any pharmaceutical products in the event of even a suspected danger to health. The evidence I shall present shall show that the Regulators sanctioned Covid-19 vaccinations despite continued evidence of harm and death caused by same.

As some of you may already know, the FDA, the U.S. medicinal product regulator met up by webinar in September 2021 to discuss whether covid vaccine boosters should be approved for use. The entire eight hour recording of that meeting is hosted in full on the FDA's own website.

One would imagine that if any of the voting FDA delegates sounded the alarm regarding heretofore unseen numbers of adverse reactions and

deaths that any such medicine would immediately be pulled from the shelves. However, I shall show that these very warnings were made in the most stark and unambiguous terms by several FDA delegates and the product was approved for use anyway.

It is noteworthy that these FDA voting delegates cite exactly the same concerns as Northern Ireland's Dr. Anne McCloskey cites [here](#) and we all know that Dr McCloskey lost her medical licence for speaking up.

At [this FDA meeting](#), each delegate is only given 2 or 3 minutes to speak so the presentations are very quick and there is little scope for boredom. One delegate, Steve Kirsch points out (and I quote) "we have killed more people than we have saved" but the booster shots were approved anyway.

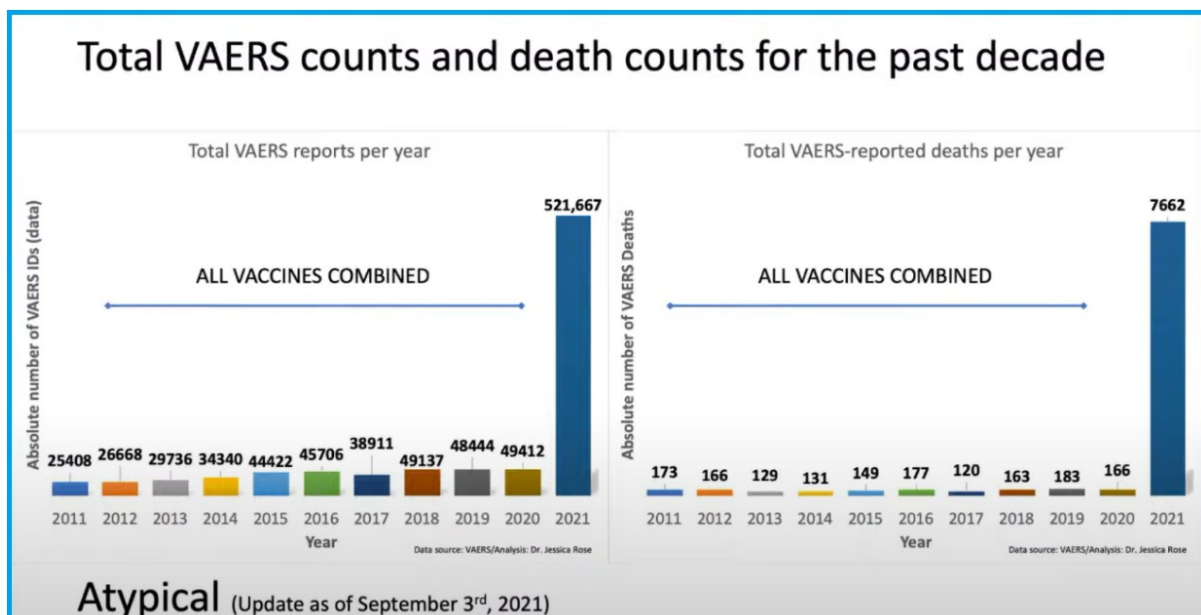
An important note to the Gardai:

The 23 minutes of evidence from FDA voting delegates from 4hrs and 10 minutes through to 4hrs 33minutes presented [here](#) is clear evidence that those in Dail Eireann voting for measures to coerce covid vaccines on the Irish people are already guilty of contributory manslaughter and causing harm (including life changing harm). Furthermore, should the Irish Government proceed with Covid-19 vaccine booster rollouts despite the evidence below then any Deputies voting to continue these policies are also guilty of pre-meditated murder.

The key points made by these FDA delegates are as follows:

1) Evidence of the harm caused by Covid-19 Vaccines that Government and the MSM hide:

The below graph ([from 4hrs and 10 minutes in](#)) is presented by FDA delegate and immunologist Dr Jessica Rose and she points to a **1000% increase in vaccine adverse events in 2021**.



Dr Jessica Rose was only given 2 minutes at the FDA meeting but she is given ample time to discuss her research on another platform [here](#)

and if the above vaccine graph of VAERS adverse event data was not shocking enough in and of itself then consider the VAERS under-reporting factor: The US Federal Agency for Healthcare Research and Quality (AHRQ) commissioned Harvard University to analyse the effectiveness of the VAERS reporting system and results of that that report (attached to this email for completeness) cite fewer than 1% of adverse events being reported so you can multiply the numbers in the above graph by 100 to get a truer picture...

Adverse events from drugs and vaccines are common, but underreported. Although 25% of ambulatory patients experience an adverse drug event, less than 0.3% of all adverse drug events and 1-13% of serious events are reported to the Food and Drug Administration (FDA). Likewise, fewer than 1% of vaccine adverse events are reported. Low reporting rates preclude or slow the identification of “problem” drugs and vaccines that endanger public health. New surveillance methods for drug and vaccine adverse effects are needed. Barriers to reporting include a lack of clinician awareness, uncertainty about when and what to report, as well as the burdens of reporting: reporting is not part of clinicians’ usual workflow, takes time, and is duplicative. Proactive, spontaneous, automated adverse event reporting imbedded within EHRs

2) Evidence of the ineffectiveness of Covid-19 Vaccines (and thereby the crime of coercing the population to take them anyway upon the fraudulent basis that they work.)

Emphasising the ineffectiveness, Professor Restev Levi ([4hrs, 15 minutes and 19 seconds in](#)): “Israel continues to have among the highest infection rates per capita in the world” (despite that nation having one of the highest vaccination rates in the world and despite the fact that they are currently rolling out their fourth booster shot).

3) Evidence of high incidence of cardiac conditions directly caused by Covid-19 Vaccines:

know they do” and “[risk of vaccine induced myocarditis \(a cardiac adverse event or CAE\) to boys aged 16 - 17 without comorbidities](#) is 2.1 to 3.5 times higher than their 120 day hospitalisation risk” (read source date [here](#)) and despite this the Irish Government are pushing these vaccines on our Nation's children without informing parents or the vaccine recipients.

4) Evidence of Pfizer trying to limit the cardiac conditions they know their vaccines cause by substituting saline buffer with heart attack drugs in the vaccines for 5 – 11-year-olds

In their recent amendment to Emergency Use Authorisation for Covid Vaccines recently submitted to the FDA, Pfizer state that they have replaced the saline

buffer in the vaccine with a medication called Tromethamine, a medication used to treat heart attacks:

People also ask :

What is tromethamine used in? ^

Tromethamine is used to treat metabolic acidosis (an electrolyte imbalance). Metabolic acidosis can have many causes. It often occurs after heart bypass surgery or cardiac arrest.

The Gardai should note that this means that Pfizer and the Irish Government are giving 5 – 11 year olds jabs known to cause heart attacks so they've added some Tromethamine to help the youngsters survive the heart attacks.

Unless the criminals in Dail Eireann are arrested first, all children in Ireland will be soon coerced by the Irish Government to take these jabs via a no jab no school policy that any fool capable of connecting the dots can see coming down the tracks. Such policies are already in place in Austria, Germany and New York


Suggested case to help the Gardai prosecute Government for causing a heart attack:

5) The absence of Informed Consent (and the attendant illegality of same)


The Irish Government coercion tactics to ensure Irish Citizens take Covid-19 vaccines via a variety of measures to restrict the freedoms unless they comply is repugnant to both the principle of informed consent and Article 8 of the European Convention on Human Rights.

The citizensinformation.ie website has the following to say about informed consent in relation to medical or surgical procedures:

The very essence of the Convention is respect for human dignity and human freedom. Without in any way negating the principle of sanctity of life, it is under Article 8 that notions of the quality of life take on significance and"

To be clear: Informed consent means informing the patient about the risks involved. Irish recipients of Covid-19 vaccines were not made aware of the vast spectrum of possible adverse reactions and attendant risks up to and including death of themselves and or (in the case of women) their infants born or not yet born. Failure of the Irish Government to inform each citizen of all of the risks associated with Covid-19 vaccinations means that from a legal perspective, informed consent could not have been given and the Irish Government are therefore contributory accessories to any harm or deaths caused by these vaccinations.

6) Quantification of the numbers killed in Ireland by Covid-19 Vaccines using FDA evidence (i.e. the numbers of Irish people murdered by the actions of members of the

Dail, the Seanad and the biased reporting of the Irish Media):

The Gardai should pay very close attention:

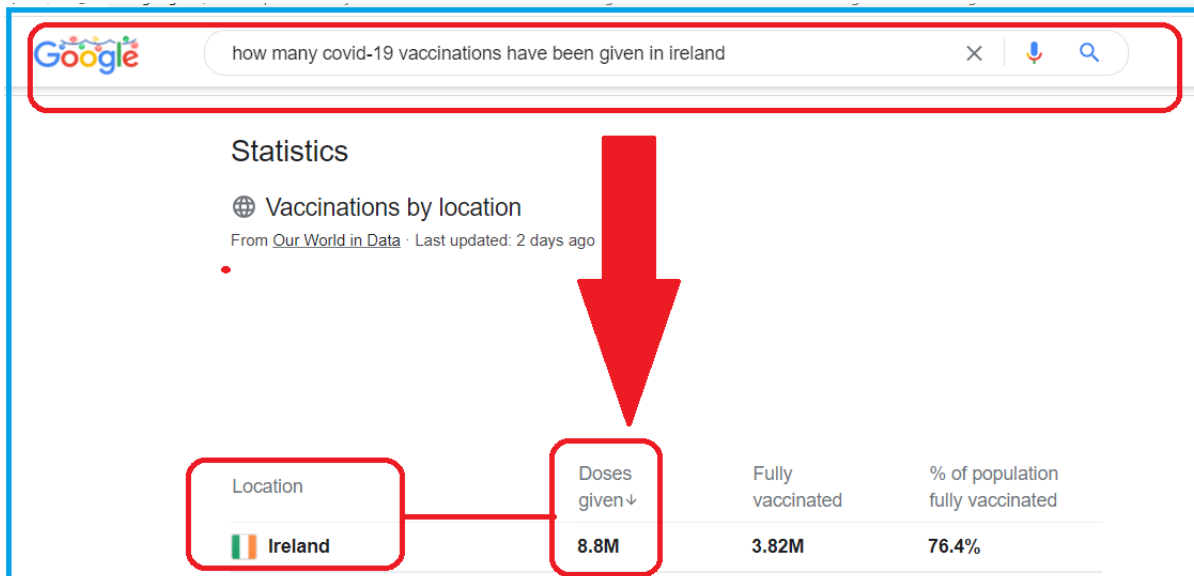
Steve Kirsch, executive director of the Covid-19 early treatment fund:

- (4hrs, 20 minutes and 23 seconds in): “I’m going to focus my remarks today on the elephant in the room that nobody likes to talk about: that the vaccines kill more people than they save.....we were led to believe that the vaccines were perfectly safe but this is simply not true. For example there are four times as many heart attacks in the treatment group in the Pfizer six month trial report, that wasn’t bad luck: VAERS shows heart attacks happen 71 times more often following these vaccines compared to any other vaccine....even if the vaccines had a 100% protection it still means that we kill two people to save one life... four experts did analysis using completely different non U.S. data sources and all of them came up with approximately the same results of excess vaccine related deaths: **about 411 deaths per million doses**....Slide no. 11, the nursing homes, now the real numbers confirm that we killed more than we saved.....50% of vaccinated people died and 0% of unvaccinated people died...unless you can explain that to the American public you cannot approve the boosters.

Note to the Gardai: The case of Roy Butler, a healthy 23 year that died within 3 days of taking a Covid vaccine will be a good starting point as an example of a vaccine induced death in Ireland and a public appeal will no doubt bring in many others.

Calculation method employed to quantify the numbers murdered by Government in Ireland by Covid Vaccination policies:

Step 1: Assess how many doses have been administered - a quick Google search reveals 8.8m



Step 2: if 411 people will die per million doses of Covid vaccine administered and Ireland has administered 8.8 million then

8.8 x 411 = 3,616 people murdered by Government so far.

....but even if it were only one person killed it would still be murder.

7) Evidence that the FDA ignored high vaccine induced death and adverse reaction rates from the very outset of vaccine rollout:

Although the [FDA meeting to discuss approval of booster shots](#) only occurred as recently as September, it is certainly not the case that the FDA only began to ignore data on adverse reactions and deaths caused by Covid vaccines in September: Recent developments have shown that the evidence of harm and death was available to the FDA from the very beginning as I will now present:

A group comprised of medical professionals in the US known as "Public Health and Medical Professionals for Transparency" (find them right [here](#)) brought the FDA to a Federal court on November 18th 2021 to force them to release the

documentation pertaining to the Emergency use Authorization of the Pfizer BionTech Covid vaccine. The FDA wanted to drip feed release the 320,000 pages of documentation at a rate of 500 pages per month - i.e. a document release that would have taken until 2076 to complete. All of this prompts the question "so what were the FDA trying to hide?" and the answer to that question is "the same thing the Irish Government, its institutions and the Irish Mainstream media are trying hide": deaths and injuries caused by Covid-19 vaccines.

The presiding judge sided with the plaintiffs and ordered that the documents be released forthwith.

Investigating Gardai should examine the "Public Health and Medical Professionals for Transparency" (find them right [here](#)) website to find the Federal Law Court documents and some of the documents the FDA had to release on foot of the court's order.

One of those documents (see the document [here](#)) detailing adverse reactions from the first two months of vaccine rollout is titled

"CUMULATIVE ANALYSIS OF POST-AUTHORIZATION ADVERSE EVENT REPORTS OFPPF-07302048 (BNT162B2) RECEIVED THROUGH 28-FEB-2021"

I have both attached a copy of the report to this email and hyperlinked to a copy online for completeness.

No doubt the medical professionals comprising 'Public Health and Medical Professionals for Transparency' would be more than willing to act as expert witnesses in a legal trials to charge all members of the Irish Government complicit in pushing these vaccines with the following charges in a court of law:

- 1) malfeasance in public office and

2) contributory manslaughter / murder charges

3) Democide

The final section of the report (see the document [here](#)) **is titled “List of Adverse events of special interest”** and takes up eight whole pages of A4.

The Gardai should note that all eight pages are completely full of text but not one of the pages in this section contains single sentence: i.e. the pages are instead only filled by a list of adverse reactions (medical names of same) separated only by a comma - yes you read that right - 8 pages completely filled only with the names of the different adverse events recorded within the first two months of vaccine roll out.

When assessing Government culpability in these crimes the An Garda Siochana should contrast this undeniably vast spectrum of adverse reactions with the information given to the Irish public by NPHET, The HSE, Stephen Donnelly et al on possible adverse reactions as contained in the scanned HSE leaflet (attached) and shown in the screen snippet from same below:

What are the side effects of the vaccine?

Like all medicines, vaccines can cause side effects. Most of these are mild to moderate, short-term, and not everyone gets them.

More than one in 10 people may experience:

- feeling tired
- tenderness, swelling and/or redness in your arm where you have had the vaccine injection
- headache
- muscle pain
- joint pain
- nausea
- fever (temperature of 38 degrees Celsius or above)






More rarely, people develop itchiness where the vaccine was given, swelling of the lymph glands or sleeplessness. These side effects are seen in more than 1 in 1,000 people. Bell's palsy is a rare side effect seen in more than 1 in 10,000 people.

Serious side effects, like a severe allergic reaction, are extremely rare, seen in approximately 1 in 100,000 people. Your vaccinator is trained to treat very rare serious allergic reactions.

It is also noteworthy that the HSE does not cite risk of death as a possible adverse event even though the Pfizer information leaflet (P.15) for Healthcare providers administering the vaccine (see that document right [here](#)) clearly cites death as a possible risk:

5. The vaccination provider is responsible for responding to FDA requests for information about vaccine administration errors, adverse events, cases of MIS in adults and children, and cases of COVID-19 that result in hospitalization or death following administration of Pfizer-BioNTech COVID-19 Vaccine to recipients.

* Serious adverse events are defined as:

- Death; 
- A life-threatening adverse event; 
- Inpatient hospitalization or prolongation of existing hospitalization; 
- A persistent or significant incapacity or substantial disruption of the ability to conduct normal life functions; 
- A congenital anomaly/birth defect; 

The Gardai should note that Pfizer mentions the above risks because Pfizer's own data shows that these events have occurred as I have shown.

The screen snippet below shows **Table 1.** within the CUMULATIVE ANALYSIS OF POST-AUTHORIZATION ADVERSE EVENT REPORTS OF PF-07302048 (BNT162B2) RECEIVED THROUGH 28-FEB-2021 (see the document [here](#) and remember that this report was prepared by Pfizer for the FDA) and shows 1223 recorded deaths occurring within the first two months of vaccine rollout. The death toll has been rising steadily ever since and neither the FDA or any other country's regulators (with the notable recent exception of Japan) have halted its roll out ever since.

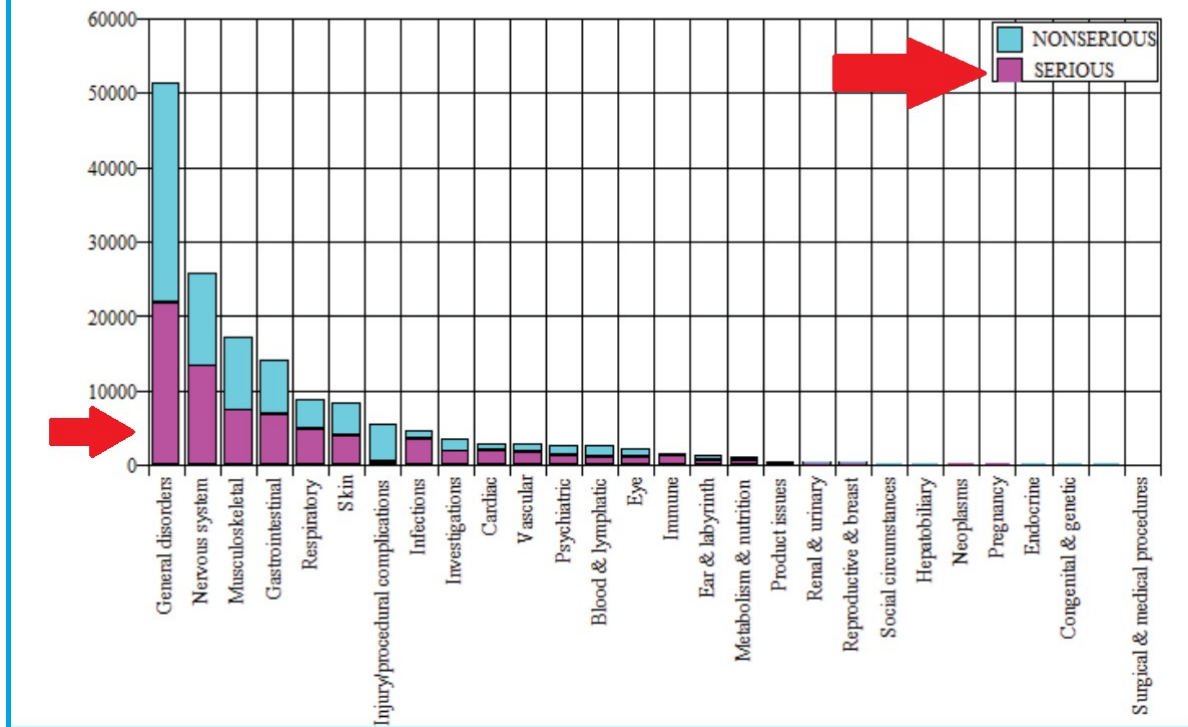

To reiterate the obvious: Should the Irish Government continue its policy to coerce the Irish people to take these Covid-19 vaccines with risks up to and including death of Irish Citizens despite the evidence presented here, then all Dail Deputies, members of the Seanad, the President of Ireland and most news pundits in the Irish Mainstream media are guilty of premeditated murder and democide or accessory to same. It behooves An Garda Siochana to act quickly to prevent future murders.

The HSE information leaflet suggests that serious side effects are nothing to be concerned about but the **categories of serious adverse reactions recorded within the first two months of vaccine rollout seen on Page 8, Figure 1** are a wide spectrum of serious adverse events:

8) Evidence of how the Irish Government have been responsible for miscarriages and stillbirths through pushing Covid Vaccinations on Pregnant women:

The Irish Government and Mainstream media have been urging pregnant women to get covid vaccines and tell women that the vaccines are safe. Here is a screen shot from the HSE website (see it for yourself [here](#)) by way of illustration that shows encouragement to get the jab and reassurances that the jab will protect the mother and the baby with no indication of possible adverse reactions:

COVID-19 is a risk to your health and the health of your baby.

Most pregnant women who get the virus get mild to moderate symptoms. They give birth as planned and the risk of passing on COVID-19 to their baby is low.

But you are more likely to get very unwell and need treatment in intensive care than a woman who is not pregnant.

The virus may also cause [complications for your baby](#), including premature labour or stillbirth. You may not have symptoms of COVID-19 when this happens.

Vaccine will protect you and your baby

Being vaccinated will reduce the chance of you becoming very unwell from COVID-19 and reduce the chance of complications for your baby.

COVID-19 vaccines are not shown to have any negative effect on babies in the womb. They may actually help to protect your baby after birth as you may pass on antibodies from the vaccine to your baby.

The CUMULATIVE ANALYSIS OF POST-AUTHORIZATION ADVERSE EVENT REPORTS OF PF-07302048 (BNT162B2) RECEIVED THROUGH 28-FEB-2021 (see the document [here](#)) report also lists a small number of serious adverse effects in both pregnant and breast feeding women. Although the numbers at that time were small those numbers have exploded since then. The Gardai should take the time to assess the most damning evidence of miscarriage, still births and other pregnancy and breast-feeding complications from multiple medical sources and government data from the EU, UK and US confirming this.

RESULTS

A total of 35,691 v-safe participants 16 to 54 years of age identified as pregnant. Injection-site pain was reported more frequently among pregnant persons than among nonpregnant women, whereas headache, myalgia, chills, and fever were reported less frequently. Among 3958 participants enrolled in the v-safe pregnancy registry, 827 had a completed pregnancy, of which 115 (13.9%) were pregnancy losses and 712 (86.1%) were live births (mostly among participants vaccinated in the third trimester). Adverse neonatal outcomes included preterm birth (in 9.4%) and small size for gestational age (in 3.2%); no neonatal deaths were reported. Although not directly comparable, calculated proportions of adverse pregnancy and neonatal outcomes in persons vaccinated against Covid-19 who had a completed pregnancy were similar to incidences reported in studies involving pregnant women that were conducted before the Covid-19 pandemic. Among 221 pregnancy-related adverse events reported to the VAERS, the most frequently reported event was spontaneous abortion (46 cases).

Despite clear evidence of harm by Governments own vaccine adverse reaction databases around the world we notice that the exact same policies are enacted globally: i.e. pregnant women everywhere have been urged to take Covid jabs. 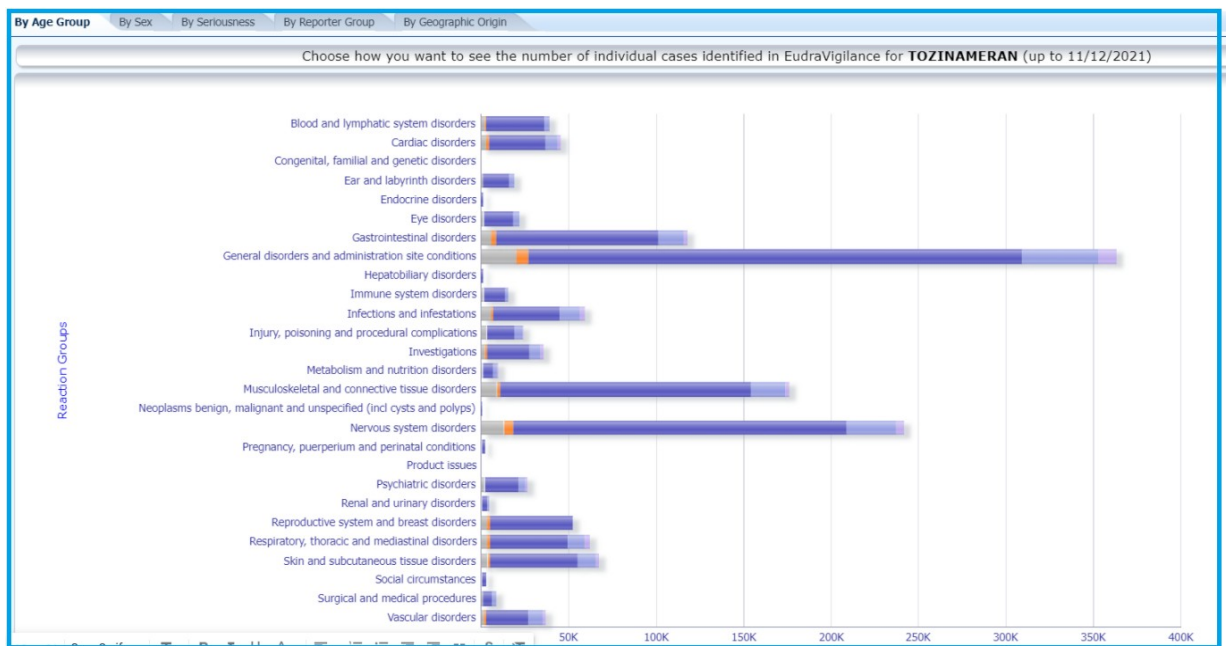

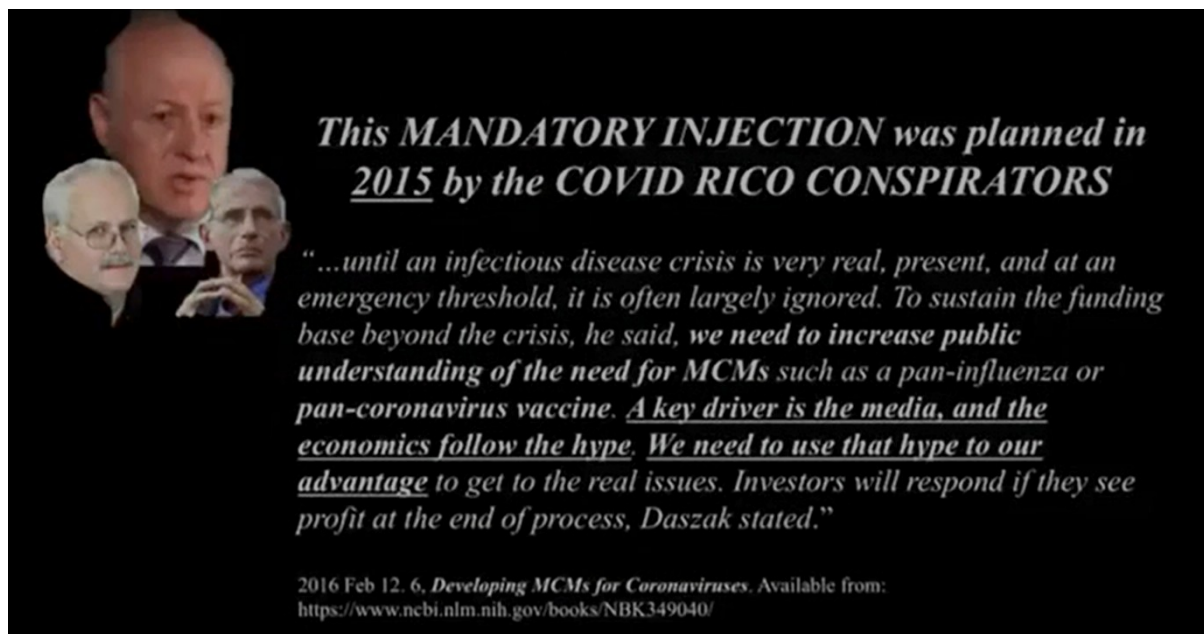
Status of COVID-19

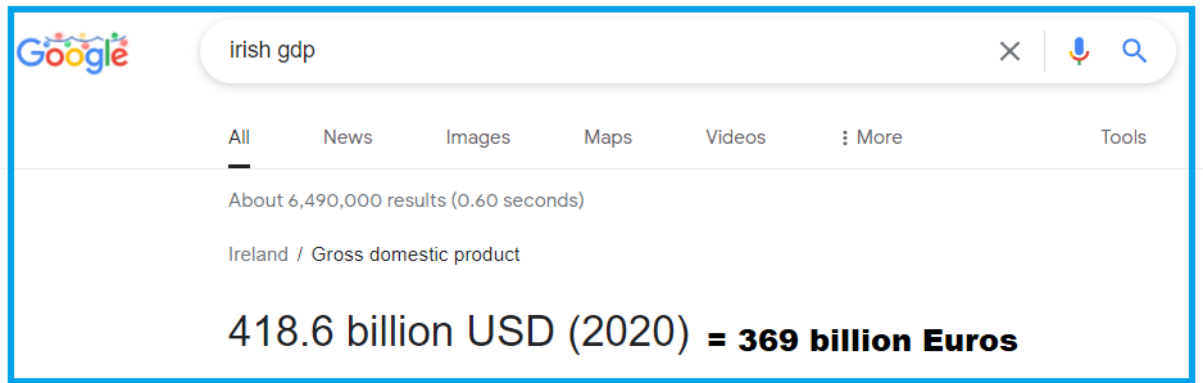

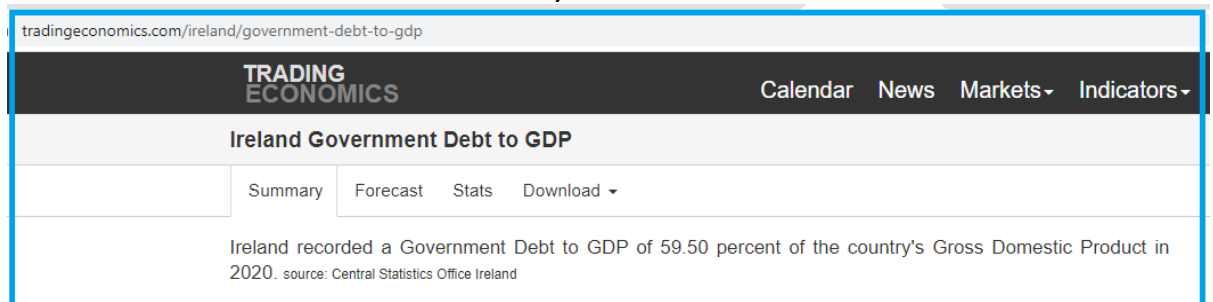

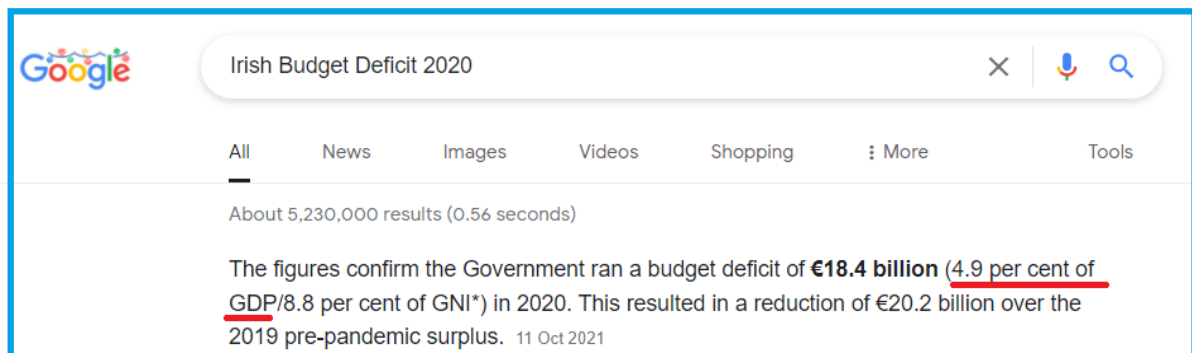

STEP 1: Introducing David Rockefeller (June 12, 1915 – March 20, 2017) was an American banker who served as chairman and chief executive of Chase Manhattan Corporation... was noted for his wide-ranging political connections and foreign travel, in which he met with many foreign leaders... was criticized for befriending foreign autocrats in order to expand Chase interests in their countries. *The New York Times* columnist **David Brooks** wrote in 2002 that Rockefeller "spent his life in the club of the ruling class and was loyal to members of the club, no matter what they did." He noted that Rockefeller had cut profitable deals with "oil-rich dictators", "Soviet party bosses" and "Chinese perpetrators of the Cultural Revolution".^[9] had a lifelong association with the **Council on Foreign Relations (CFR)** when David Rockefeller joined as a **director** in 1949.^[35] .. **Displeased with the refusal of Bilderberg Group meetings**

to include [Japan](#), Rockefeller helped found the [Trilateral Commission](#) in July 1973

STEP 2: David Rockefeller's open admission [in his autobiography "MEMOIRS"] of seeking to use Rockefeller family influence to bring about a one world government:

"For more than a century, ideological extremists at either end of the political spectrum have seized upon well-publicized incidents such as my encounter with [Castro](#) to attack the Rockefeller family for the inordinate influence they claim we wield over American political and economic institutions. Some even believe we are part of a secret cabal working against the best interests of the United States, characterizing my family and me as 'internationalists' and **of conspiring with others around the world to build a more integrated global political and economic structure — one world, if you will. If that is the charge, I stand guilty, and I am proud of it**". – David Rockefeller 2003

General social and economic progress is no less impressive....The enormous social advances of China have benefited greatly from the singleness of ideology and purpose.... 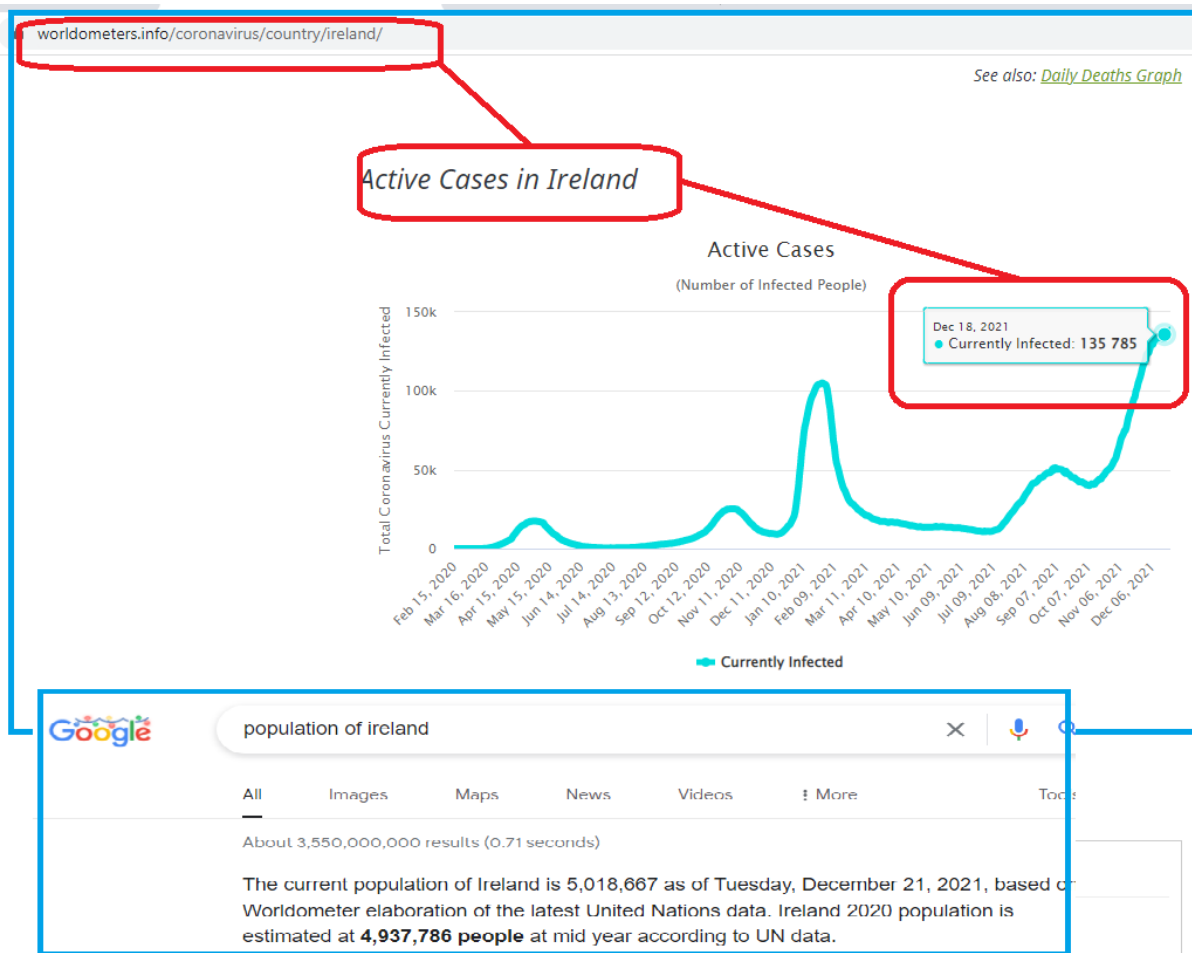
